## 2. Document(s) from Transferor

(A) If the Transferor is an individual residing in Hong Kong, a copy of the Hong Kong ID card of the individual or the passport of the individual. If the Transferor is 11 years and older and under 18 years of age a copy of the Transferor's parents'/guardians' Hong Kong ID cards or passports together with a Certificate of Birth or Certificate of Guardianship.

(B) If the Transferor is an individual outside Hong Kong, the original completed and signed **Declaration Form DCTNR2** together with a copy of such document that proves the legal identity of that individual (such as a passport or ID card<sup>1</sup>)

## 3. Document(s) from Transferee
